#### Serena #1

Serena Williams regained the top ranking she held more than five years ago by winning the US Open for the third time. Williams defeated Jelena Jankovic 6-4, 7-5 in a very well-played and intense women's final. The victory gave Serena her ninth Grand Slam title and put an American at the top of the women's rankings for the first time since August 2003.

The Williams sisters, Serena and Venus, have definitely contributed to the improved level of women's play in professional tennis. Serena hit serves up to 120 miles per hour and won the US Open title without dropping a set. In the quarterfinals Serena beat her older sister Venus 7-6, 7-6 in two tie-breakers.

#### Federer wins fifth open

Roger Federer defeated Andy Murray 6-2, 7-5, 6-2 to win his fifth consecutive US Open Championship and his 13<sup>th</sup> major title. The win returns Federer to the #1 men's ranking and moves him within one major championship of tying Pete Sampras' career record of 14 majors.

Andy Murray, playing his best tennis ever, upset Rafael Nadal, the #1 seed, in the semifinals to reach his first Grand Slam final. Andy had a career 2-1 record against Roger going into the final.

## **Tennis in the Northland**

#### A history of boys tennis in Minnesota

If you are a former or current high school tennis player, coach, or fan of tennis, you will want a copy of this 75year history of boys' high school tennis in Minnesota. The book features narrative profiles of (1) all the singles and doubles champions from 1929-2003; (2) prominent tennis coaches and families; (3) dynasty teams--Edina, Blake, Rochester, St. Cloud, Blue Earth; and (4) Cinderella teams such as St. James, Minnehaha Academy, and Minneapolis South. There is also a chapter on the unpredictable weather that often plagues Minnesota tennis players in the short spring season and another titled "Girls Playing on Boys' Teams Before Title IX." This last chapter includes the remarkable story of Peg Brenden, a plucky young woman who sued the State High School League so she could play on the St. Cloud Tech boys' team in 1972.

Readers will also discover many fun facts about former champions. For example, 1951 singles champion Vincent Bugliosi was the lead prosecutor at the Charles Manson trial (and author of the book *Helter Skelter*); another (Bill Arnold) is one of the creators of the play

"Triple Espresso"; one had a tennis scorebook named after him (John Wirtanen); and still another (Jack Thommen) took a lesson from tennis champion/hustler Bobby Riggs.

Former U of M men's tennis coach Jerry Noyce calls *Tennis in the Northland* "a remarkable history of high school tennis in our state--a must-read for all of us connected with Minnesota tennis in any way." And two-time singles champion Mark Wheaton from Minnetonka (brother of David) calls it "the definitive and complete history of Minnesota high school boys' tennis that will come to be recognized as the bible of Minnesota high school tennis." There is also a foreword from Steve Wilkinson of Gustavus Adolphus College, arguably the greatest Division III college tennis coach in the nation.

Jim Holden, a former English teacher and boys' tennis coach at Northfield High School, wrote this book to honor and remember Minnesota tennis players and coaches. With its attractive dust jacket cover and over 180 photos of players and coaches, the book would be an excellent addition to anyone's sports book collection. It is hardcover, 8½ by 11 inches, and 448 pages.

2. I served wildly—it hit the racket of receiver's partner **before** touching the ground. **My sides point!**. [Rules, #24, Case 7]




