They died two days apart. Bob, a neighbor of mine and an avid tennis player, had a heart attack on the tennis court near Cross Lake, in north central Minnesota. ICT Bearpath Clay Tournament

Bearpath Country Club was the beautiful site of the InnerCity Tennis Men's Senior Clay benefit tournament for the 9th consecutive year. Due to the large draw and rain during the week some of the matches were played at Interlachen Country Club in Edina.

Eleven members of STPC won or reached the final in the regular draw or consolation of the InnerCity Tennis Men's Senior Clay Tournament held during eight rainy days, August 7-14. The members were Doug Farrell, Richard Faunce, and Jack Harkness in 80 doubles; Steve Caruso in 75 singles; Dick Mills, Paul Stormo, Bruce Mikkelson, Joe Emond and Bob Busch in 70 doubles and singles; Rich Naistat in 60 doubles; and Mark Ottum in 55 singles and doubles. This remarkable performance was achieved while playing a tournament that included many highly-ranked players such as David Nash, an internationally-ranked 65 player from Bloomington, and Leslie Curtis, a highly-ranked 50 player from Shaker Heights, Ohio.

All singles and doubles categories have new champions in a very strong field of play. David Nash won 55 and 65 singles and 50 doubles with partner Leslie Curtis. Tom Boice won both 55 and 65 doubles with partners John Shannon and Jerry Noyce, former Gopher player and coach. Ed Hoffman won 75 singles and doubles with partner Don Herrick, and Bob Busch won 70 singles and doubles with partner Tom Fridinger. Thanks to a great committee of hard workers, the tournament was a financial success with the help of co-sponsors Chris Wagner of Wagner Investment Services and Estate Planning and Chris and Patty Clifton of Southview Design. There are advantages and disadvantages to the ladder format I use.

Advantages are:

- You play only with players your own skill level which tends to make better, more competitive matches for more fun.
- Ladder rankings are determined by performance, not someone's opinion.
- If for any reason you cannot play or do not want to play on any particular day, you don't have to get a sub (there are no subs) or tell anyone; you just don't go and we play without you.
- It is cheaper because there are more than 4 players paying for one court.

Disadvantages are:

- You have paid for the right to play whether or not you actually play.
- You might have a sit-out (about a half hour) when we have more than four players on a court.

In Memory...



Uwe Habeck

Habeck, Uwe Eric age 74, of Bloomington. Retired Chemist at Valspar. Born June 27, 1936 at Stettin, Germany. Passed away July 29, 2010. Survived by wife, Irmi;



daughter, Heidi & husband Darrell Johnson; brother, Klaus Habeck; sister-in-law, Maria Nyman; and many nieces, nephews and other relatives in Germany and many friends. Uwe was a member of Senior Tennis from 1999.

Linda Wright remembers Uwe: "He was a Paint Chemist for the Valspar Paint Company. He was always trying to improve the primers and paints. He dove down by the Onassis Ship and they tested paints and primers for that ship to improve it as they have to withstand all kinds of weather, water, barnacles and such. He would hang panels on the ship with the different products to test it. They made the paints for the John Deere Tractor Company too.

"Eric and Irmi used to go to Acapulco in the winter with friends. He loved to swim and he even spent hour after hour teaching a little girl how to swim one winter.

"When they went to Puerto Vallarta he enjoyed talking to the residents in Spanish and they loved it that he spoke their language.

"Irmi and Eric were both from Germany, but she met him at the Y in Minneapolis. She was having lunch at the Woolworth Dime Store in Minneapolis and met a young lady with the American Youth Hostel who suggested they go to the Y for a dance that evening, and they did. Irmi says he was a very good ballroom dancer and they danced often."

Uwe's wife Irmi adds more: "When World War II came to on end and the Russians were advancing west, the town mayor had everyone leave within 24 hours. They packed whatever they could carry and joined a long caravan heading west. Uwe was 9 years old, his sister 3 and his brother Klaus 2 years old. Along with them was a grandmother who they eventually left behind with a relative who stayed. It was a chaotic time. All the rail lines westward were blocked. They ended on a boat which got stuck and then transferred to another boat that took them to Denmark. (Had they stayed on the first boat, they would have

died, as that boat was torpedoed shortly after.)

"Once in Denmark, the Danes put them in barracks behind barbed wire but they fed them and were very kind to the refugees. They stayed there for two years during which time little sister Karin died of diphtheria. The children continued to get educated as there were many talented people also interred with them and could teach. There was no writing paper or pencils available to them. Overall, Uwe said it was an interesting experience. He sneaked out under the barbed wire in the dark to visit with some Danes.

"Eventually the family reunited when the Red Cross found their father. Things had stabilized enough by then so that they could settle in Kiel, also on the Baltic Sea, where they lived in barrack-like conditions for a while until the authorities procured proper housing for them.

"Uwe came to the United States in 1959 through a coworker back in Germany who had settled in Minneapolis and wanted Uwe to join him. There would be a job waiting for him at Valspar Corporation, which was then called Minnesota paint. He quickly assimilated and loved his work."

Ardelle Hansen tells us that Uwe and **Bob Levy** especially enjoyed playing tennis with each other, and had a similar off-beat sense of humor.

She especially loved her new experience with Senior Tennis. She'll be remembered as a great player and advocate for the game."

The Percy Hughes Clinic will be held the first week of June, 2011 at the Reed-Sweatt Family Tennis Center.


Lessons at Bryant ParkBy Chuck Supplee

Thanks, George, for all you did!


