TENNIS TIPS

Checklist for the Forehand

 Keep your eyes on the ball throughout the stroke.

 Get your racket back as early and as quickly as possible.

3. Hit the ball opposite your forward

 Use a firm wrist and grip at the point of contact with the ball.

 Hit through the ball and make a long, high follow-through.

Low Forehands

When the ball bounces lower than your waist, get down to the ball by bending your knees and flexing your body. You can sight the ball better because your eyes will be nearer its line of flight. Straighten up only on the follow-through.

Cures for Erratic Ground Strokes

 Tighten your grip. Squeeze the racket tighter and your wrist action will be reduced automatically.

Keep a firm forearm. Keep your wrist firm and swing your hand forward so that the racket head moves along the line of flight of the ball before and after contact.

3. Hit through the ball. Control comes from long contact of the racket on the ball. Keep the ball on the strings for as long as possible by hitting through the ball.

Doubles Tip-Move Together

Moving together is the most important element necessary to good doubles play.

The key to moving well together is simple. Just remember to play the percentages by edging over to the same side of the court where you or your partner have just hit the ball. This same shifting principle applies to forward and backward motion, too; advance together and retreat together.

Use this tandem rule even if you've never played with a particular partner before and aren't acquainted with his or her style of play. It will help compensate for your unfamiliarity.
