Roster



TRUE SPORTSMANSHIP

Many times in a rally a player is presented with a short ball, generally inside of the service line. Return of this "lame duck" short ball should be the point maker. Where to place it? You have options. In doubles, the #1 return is up the middle between your opponents. The #2 return is the sharply angled shot away from either player. The return to the shoelaces is also a winner.
