

#### The Hop

Hop straight up in the air as your opponent is about to serve to you. Your natural inertia wants to keep you standing still. Well, that little hop breaks the inertia and gets your body moving. It picks up the pace of your game, makes you concentrate better, helps you get to the net faster, and helps destroy the tendency to laziness. Get the hop into your game!

#### After you Hit the Ball, MOVE.

Regardless of what shot you have just made--be it service, volley, return of service, overhead smash, drop shot or lob--if you do nothing else, MOVE! This forced movement will make you conscious of where you should be at any given time.



## FROM THE 1988 USTA RULES OF TENNIS AND CASES AND DECISIONS Rule 17. The Ball in Play

A ball is in play from the moment at which it is delivered in service. Unless a fault or a let is called, it remains in play until the point is decided.

USTA Comment: A point is not decided simply when, or because, a good shot has clearly passed a player, or when an apparently bad shot passes over a baseline or sideline. An outgoing ball is still definitely in play until it actually strikes the ground, backstop or a permanent fixture (other than the net, posts, singles sticks, cord or metal cable, strap or band), or a player. The same applies to a good ball, bounding after it has landed in the proper court. A ball that becomes imbedded in the net is out of play.

Case 1. A player fails to make a good return. No call is made and the ball remains in play. May his opponent later claim the point after the rally has ended: DECISION. No. The point may not be claimed if the players continue to play after the error has been made, provided the opponent was not hindered. USTA COMMENT: To be valid, an out call on A's shot to B's court, that B plays, must be made before B's shot has either gone out of play or has been hit by A.

Case 2. A ball is played into the net; the player on the other side, thinking that the ball is coming over, strikes at it and hits the net. Who loses the point? DECISION. If the player touched the net while the ball was still in play, he loses the point.

We are in need of captains for Decathlon, Nicollet, Northland and Wooddale so if you are willing to offer your services, please call Al Mohr - 722-8339.


#### DOMINO'S PIZZA LEAGUE





#### UP CLOSE AND PERSONAL

Chicagoan Marie Shaw Wolpert came to Minneapolis for a one-week gig to sing in the Panther Room at the Minnesota Hotel in 1949. She's called Minneapolis her home ever since.

She sings and acts at commercial and industrial trade shows, and is branching out as a concert singer and entertainer. In 1983 she formed her own production company, Lady Slipper Productions, to manage and promote her own and other's careers.

When she's not working, Marie is playing tennis. She took up the sport at the age of 47, and first took lessons from Jerry Noyce, now director of the North-west Racquet Clubs. That was in 1963. Now she plays at the Decathlon Club three times a week. Meeting her friends there, she says, is "just like going"

home." She joined STPC at its inception and considers it her "access to wholesome activity and social expression—a superb way to establish support with the rest of one's life."
