#### Ernie Greene Wins in National Public Parks Finals

Nearly 500 players from throughout the United States competed. This is the third time for Ernie in this tournament, having won in 1979, then coming back and winning in 1985.

#### **Permanent Court Time Reservations**

#### HOW AND WHEN DO I SIGN UP?

Permanent court time reservations are being accepted NOW for the indoor -playing season. The season runs from September or October (depending on location) to April or May, 1993. Check the schedule in this Senior Tennis Times, select the location, day and time that suits you best, and then call the captain to sign up. Remember, reserving permanent court time is a commitment to play EVERY WEEK.

#### HOW MUCH DOES IT COST?

The cost for permanent court time varies by location. It averages \$5 per person for two hours (40% - 50% less than usual fee) - and you don't have to pay the host facility's membership fees!

#### WHAT HAPPENS IF I HAVE A CONFLICT AND CAN'T PLAY?

Players with permanent court time must be prepared to provide a substitute if they can't play. If the substitute you line up doesn't show, you are still responsible for the court fee. Not only that - the other three players who counted on you for doubles will be very disappointed!

## WHAT IF I'M NOT INTERESTED IN A WEEKLY COMMITMENT, BUT WOULD LIKE TO PLAY NOW AND THEN?

You can sign up as a substitute. Call the court captain NOW and get on the substitute list. The lists are given to the regular players, who use them to arrange for subs when they need them. Subs are in demand, and you have a good chance of being called to play if you're on the list!

#### I STILL HAVE QUESTIONS. WHO ANSWERS THEM?

Court captains can give you details on starting dates, fees, playing rotations, etc. Just remember, all captains may not operate the same.

## I HEAR THAT NEW MEMBERS ARE ENTITLED TO FREE TENNIS LESSONS. IS THIS TRUE?

Yes! An important objective of the club is to encourage more people over 50 to learn tennis. New members are entitled to 12 free tennis lessons.

#### WHERE ARE THESE LESSONS HELD?

A schedule of lessons and drills is listed in this Senior Tennis Times. You don't have to register or commit to an entire season - just pack your racquet and show up. Balls are provided. If you have questions, call the instructor listed - the instructor will be glad to talk with you.

## Tennis Tips by Ernie Greene

## Drive the Ball with your Trunk

Many players think they must really hit the ball with their arm in order to generate racquethead speed. Actually, this is one of the worst things

they could do, since it may put too much stress on the arm, and it isn't even the most effective source of power.


The power supply for most strokes comes from the larger body parts, meaning the legs, hips and trunk.

It's true that the arm does provide some force in the shot, but the primary function of the arm is to guide the racquet into the ball. Since control is the name of the game, driving the ball with the trunk rather than the arm is a crucial component of hitting the shot efficiently.

Instead of trying to swing hard, say to yourself, "Drive the ball with trunk rotation," and remember, the key to good ground stroking is early preparation.





## Leonard Brawerman Epitomizes Senior Tennis; Music is His Other Life's Passionate Pursuit

Like the proverbial David of biblical lore, Lenny Brawerman, 78, has been a nemesis to would-be Goliaths on the tennis courts for a plus 65 years. He has a self-assured skill that belies his size which wringing wet approaches 5'6" tall. But when he pounds a tennis ball, suddenly he's a graceful giant who gobbles up winners like David Wheaton on one of his better outings. Well, maybe Lenny doesn't serve quite as hard!



A fixture on the Minneapolis tennis scene for more years than he cares to remember, he is above all a masterful teacher of the game without being a certified professional. No matter what age you answer to, Lenny can develop your skills with a pattern of qualified drills that elevates your abilities to Foshay Tower heights. He verbally makes a point so you can get a point, with a determined but gentle intensity. As a lifelong people person, he is able to communicate with his charges with an extension of

his own effective personality.

What better place to be born in than Swedish Hospital many sets ago. It was the center of the medical hierarchy and birthplace of a multitude of prominent Minneapolitans. The family name, Brawerman (pronounced brah-er-mahn), emanated from his grandfather in Germany, a brewery man, hence Brawerman. Lenny may well have originated today's beer advertising terminology because of his diminutive weight at birth...a Brawerman Lite. With a pun like that, his grandfather must be turning over in his bier!

A West High School graduate, Lenny occupied first chair in the school orchestra's clarinet section. For those of you not versed in musical protocol, first chair either denotes you're the best player or are dating the leader's daughter. Actually he blew a mean "licorice stick" and to this day tootles an artistic arpeggio flawlessly.

After a year each at Saint Thomas College and the University of Minnesota (where he played with latter marching band and concert and symphony orchestras), Lenny dropped out of school because of financial reasons to work for an uncle in the produce business in Windom. It was a move from punching clarinet keys to plucking chickens to feather his meager cash nest. At this point it's best to recall he had started working for his father, an electrical contractor, at age 10. It would later become Lenny's main profession until he retired (or rewired) in 1983.

After working in a defense plant circa early World War II, he joined the Electrical Workers Union Local 292 and temporarily joined his father in the business. In January 1943, then married to the former Ruth Badiner, the Brawermans moved to Kansas City. Lenny became a construction worker for the Pratt-Whitney Co., then the world's largest manufacturer of airplane engines. While Ruth and





Lenny were eating out one evening, Ruth, pregnant with daughter Mindy, got wedged in a restaurant booth and couldn't budge. Lenny offered the manager the cost of dismantling and paying for a new booth, but Ruth finally wriggled out by a millimeter to save the day. Lenny must have forgotten that Vaseline may have turned the trick!

In several months, the Brawermans tired of Kansas City and moved back to Minneapolis. Lenny caught on with the Cargill shipyards in Savage as an electrical wirer. Because of intestinal problems, he didn't pass the army physical, but continued in defense work to contribute to the war effort. With completion of the Savage stint, he worked for Sterling Electric Co. who are still active in business today.

With a lot of experience under his belt, Lenny rejoined his father at Lyndale Electric Co. The firm established such an excellent reputation for high quality work and service, they never had to submit estimates. For some 36 years, Lenny ran the electrical contracting business until retirement of both himself and dissolution of the company. He had achieved a career of pride in his work and the respect of the community for integrity and accomplishment.

He has never retired, however, from his beloved musical activities. After playing clarinet and saxophone for over 60 years with Union bands, Shrine and American Legion bands, Hopkins Westwind and Civic bands and the Normandale College band, he took up the oboe about eight years ago and thereby hang a few tales. One version is that he forgot the reed one day while concertizing and the other has to do with a food particle stuck in the reed's passage where nary a sound came out. Such are the trials and tribulations of a virtuoso!

Lenny started his tennis tour at age 13 on Bryant Square near 32nd Street. His early competition came from neighborhood youngsters like himself. Then it was on to the old Parade Grounds courts, endearingly termed the "gravel pit," where it seems that everyone who ever knew the game fashioned their game on the alleged clay. At one point, Lenny

became president of the club that existed for a time. The old cagey veteran, Jack Dow, was a regular at the club and played with Lenny all the time. It was there Dow got the concept of starting a Senior Tennis Club for over 50 veterans, today affectionately known in brevity as the STPC. A member of the Northwest Racquet Club also, Lenny did most of his playing at Northstar.

As a volunteer teacher for the STPC gang, Lenny confines most of his expertise to Wolfe Park. On the family side, wife Ruth passed away in 1959. Several years later he married the former Muriel Bernstein who died in 1988. Son Steve is a Minneapolis doctor while daughter Mindy is a housewife in Saint Louis Park. There are eight grandchildren and five great-grandchildren in the Brawerman menage—but no oboists.

His philosophy of life is based on the premise that "everyone has a right to their own opinion and choices and be fair to everybody." Besides his tennis and music, Lenny loves the theatre and dancing. Too bad the Marigold no longer stands!

He has played in innumerable senior tournaments and more likely than not has won his lion's share. He counts as a most memorable moment his Jack Dow-promoted trip to Wimbledon a few years ago. Laver, Rosewall, Seixas, Ashe, Trabert, Wade, Evert, King and many more of the world-ranked players walked by just like ordinary tennis players-but it was a thrill nevertheless.

So there you have it: tennis afficianado, music master, teacher and a man without conflict. If that doesn't scan the fullness of his life to the minute, what more does?




