# **A Smashing Success!**

### John Bolger Clinic and Luncheon Well-Attended

Some 100 tennis enthusiasts participated in the Fifth Annual John Bolger Clinic and Luncheon at Nicollet Tennis Center on May 20. The clinic is named to honor the memory of former board member and original by-laws framer, John Bolger. Bill Connell and Ron Liddiard co-chaired the event, along with committee members Winnie Lund, Mary and Chuck Wenz, and Ronnae and Howard Wagner. STPC president Dick Lidstone presided over the affair. (Sue Larson, former STPC president, encouraged John and his family to sponsor the tennis clinic.)

Supervising tennis drills and play was Roger Boyer, assisted by fellow professionals Paul Stormo, Lynn Olson, Jim Martin, and Arven Cohen. Genevieve Bolger and son Dik, representing sponsor Bolger Printing Co. of Minneapolis, were honored guests, who in turn welcomed their friend, Marie Shaw Wolpert, to the affair.

STPC member and *Times* contributor, Norm Diamond, delivered a eulogy in remembrance of John Bolger. He cited Bolger as "one of the kindest, gentlest and most generous men he ever knew." Dia-

mond spoke about Bolger's background, in part,
"he turned down four college scholarships to
help his father produce two newspaper weeklies before being driven out of business by a
large daily publication. With wife Genevieve, the
Bolgers started a small printing firm which today is a multi-million dollar business."

In 1959 Bolger was called on by civic leaders to build a rapport between Indians and Afro-Americans, and to forge a cooperative bond. His efforts resulted in the formation of the Twin Cities

Opportunities Industrialization Centers (TCOIC). This later expanded to state and national Opportunities Industrialization Centers, which are still going strong today.

Bolger's relationship with Indian cultures was particularly legendary. Clyde Bellecourt, noted Indian leader, gave the eulogy at Bolger's funeral highlighted by an Indian drum ceremony reserved only for a few distinguished citizens. The peace pipe he received was passed down to his late son, Jack, and then to Jack's son, Isaac.

### Battle of the Big Bands


Join STPC members in attending the Battle of the Big Bands at Orchestra Hall on Friday, June 20. This concert will resemble a 1940s radio show.

### Update: STPC TeamTennis 1997

The captains have been appointed and the courts reserved. All that remains is for the fun to begin June 17, the first day of TeamTennis play.

New this year: teams have been organized according to skills. Players rated 3.0-4.0 are grouped together on opposing teams, designated Level A. Likewise for players rated 3.0 and below, who are designated Level B.

Under this system two separate entities have been created where formerly there was one. More uniform play is anticipated with the change.

As before, each team consists of four men and four women. Mixed doubles, men's doubles and women's doubles are scheduled. Play will be on Tuesday mornings, and the eight game Pro Set method of scoring used.

The entire TeamTennis program runs eleven weeks. The two top teams in Level A and Level B will vie for the championship on August 26, concluding the program.

Coordinator John Connelly is delighted with the response from newsletter ads soliciting participation.

"We have approximately 160 players signed up,"
Connelly said. "Last year there were around 100.
We hoped to expand the play by having players of
like skills compete with one another instead of lumping all levels of play together. It worked! We have
players for sixteen teams."

"This year's success is due largely to the TeamTennis coordinating committee," Connelly added. "That includes Jan Hagen, Jack Wallin, Carol Hall, John Stecklein, Deni Sahr, Chuck Emme, Marianne Davidson, Roy Rincon, Ed Munson, Grace Dahlbeck, and Carol Curry."

# **Captains' Profiles**

### **Marianne Davidson**

After six years of captaining at Wooddale, Marianne Davidson has called it quits.

Davidson's Friday morning mixed doubles team will miss her. She ran a tight ship and it paid off. By choosing players of like skills and insisting on gender equity, Davidson ensured that her team, myself

included, enjoyed consistently good competitive tennis.

A successful tennis team is just one of many of Davidson's well deserved payoffs. Some others: A Merit Scholarship for outstanding scholastic achievement in high school. Bachelors and Masters degrees in education. The satisfaction of having successfully juggled the demands of a teaching career with rearing a family of four. Pride in having helped mold her children into responsible, successful adults.

And—prowess on the tennis court. For this, Davidson joined STPC in 1991 and took lessons from Virginia Morgan. Additional lessons at Lakewood College, "in a class with 18-year-old girls," improved her game further. Davidson then attacked tennis with a vengeance, "playing eight times a week." But first came her unusual initiation. In 1989, after retiring from teaching, Davidson moved to Australia to provide temporary care for her daughter Jan's two children. A Brisbane woman started Davidson on tennis with the "pantyhose" method of practice. With a tennis ball in one leg of a pair of pantyhose, the other leg tied to a clothesline, Davidson whacked the ball, which flew back at her for another whack, and another and another!

This modest no-nonsense woman could boast of still more achievements, although she never would. Among them: learning golf, bridge, and downhill skiing (with the local women's Wipeout Ski Club) along with tennis after retiring.

And Davidson's no wimp when it comes to travel.

While living in Australia, she toured the exotic ports of Tasmania and Fiji, learning of many native customs, most notably cannibalism, recently practiced there. But roughing it hard-core with a busload of Australians on a two-week safari through the barren Australian outback outdoes Fiji or any trip anywhere. It's in a class by itself.

"Everything—food, fuel, water—was carried on the bus because there was no place on the route to get anything. There were no motels, no road signs, no convenience stores, not even a real road," Davidson said. "We camped out, two to a tent. If we left our sleeping bag we had to check it for snakes when we came back. I'm glad I did it once, but I'd never do it again."

Davidson was married to Francis (Dave) Davidson. He died of a heart attack in 1994. She displays a wonderful photo in her living room of Dave in uniform during World War II when he was a paratrooper.

The Davidsons together enjoyed STPC tennis. They lived in Little Canada and Maplewood, where Marianne lives today. Dave worked as a leader for Saint Paul Harvester Co. During her 38 years in education, Marianne taught grades 4 through 7, and, later, English as a second language, at Saint John the Evangelist and Como Elementary Schools. She attended Hamline University and is degreed from the University of Minnesota. Tiny Browerville, Minnesota is her home town.

The Davidson's son and three daughters are in professional careers in the fields of medicine, law, teaching and library science.

Davidson's replaced captaining for STPC with a stint on the Board of Directors. Installed in April, she's already pitched in and worked on two committees. The major responsibility of planning tennis programs and locating new tennis facilities in Ramsey County also has fallen to her.

Yet, Davidson, with characteristic downplay, described her life as "pretty dull." Not so, Marianne. Not so! ■

# **Love Stories**

### Bev Sinniger, Pioneer Programmer for Women

The pretentious English economist, John Maynard Keynes, once said: "education is the inculcation of the incomprehensible into the indifferent by the incompetent." To Bev Sinniger, who has spent a considerable slice of her life in education and journal-

ism, "them's fighting words." A pioneer for some thirty years at the University of Minnesota's Continuing Education and Extension for Women, Bev is an expert specialist in a substantive field. If the world should blow itself up today, the last audible voice would be Bev saying, "It can be done."

Since her graduation from Aquinas High in LaCrosse and subsequent BA in journalism from the University of Wisconsin in Madison, Bev has been burning the track to achieve more status for women in the educational arena. She went on to the Uni-

versity of Wisconsin in Milwaukee to garner an MA in adult education and communications with a minor in photography.

After her BA degree, she went to work for the LaCrosse Tribune as a cub reporter. Then from 1956–58 it was to Guild Publications in Saint Paul as assistant advertising director and writer. She switched for the next two years to weekly newspapers in West and South Saint Paul as a writer/photographer. Advancing next as editor of Catholic Miss, a national publication for young girls, she was on her way to a major career at the University of Minnesota. For a warm-up, she became editor of Minnesotan Magazine at the U of M before culmination of the thirty-year stint with continuing Education and Extension for Women at the U.

With a Carnegie grant in her grasp, she pioneered programs and coordinated seminars for women called

"New Worlds of Knowledge," both innovations of a highly creative mind. With her reputation now bounding and leaping, she would fly up to UMD to set up programs and develop courses for non-credit in the Extension scene of action. Sinniger conceived a Research Exploration program (a first) for the labor field. With help from the National Science Foundation, she originated from twelve to eighty-eight research programs and worked with U of M teachers to enhance their courses. Sinniger also developed non-credit lecture series that were Minnesota-oriented for adults, and created study travel tours to the USSR, Yucatan, and many other world sites of interest. Although she officially retired from the U in 1990, she still coordinated U Elderhostel programs in Itasca State Park.

Sinniger is a published photographer and lists the outdoors, traveling on houseboats and RVs, history and tennis as her main hobbies. She confesses to being a Democrat "because I'm liberal," she'll say. Her pet peeve is the driver who honks his horn at her when she's already doing 65 on the highway and then gives her the finger. To make a contribution to learning by working in education and make it available to the general populace is her philosophy—and it excites her no end.

A member of the STPC for several years, she organized the first singles party for women and served as a captain at Wooddale. Leadership comes natural to Sinniger and she pulls no punches when directly queried on a sensitive subject. She can laugh at problems and get serious while discussing today's youth. "Our young people are dealing with many pressures today and should have a secure home life and be involved in school activities," she admonishes. Sinniger is unmarried but has "great siblings and nieces and néphews in LaCrosse."

Seafood and blueberry pie are her favorite foods and Chardonnay her wine choice. She plows through history books and is erudite on details of famous world figures past and present. Sinniger volunteers for Little Brothers and helps stage dinners for these elderly friends; assists at her Nativity Parish; records for the blind and is active with Store to Door (shopping and delivering food for the elderly). To keep the pot boiling, she freelances for the Oakdale Clarion and Catholic Spirit publications as a feature writer and photographer. Her greatest accomplishment: developing research explorations while connected with the U of M.

Knowing Bev, she'll never cease accomplishing but keep rewing up that motor. Charge! ■

# Playing Nice: Encouraging Civility on the Courts

There are rules and customs governing the playing of tennis that promote fairness and civility. Some of you might not be aware of them—after all, how many of you have read the USTA Rule Book? Here are a few "rules of the road" that are frequently violated. Look them over and mention them to your playing group if you think they're being ignored. Playing nice makes tennis so much more enjoyable for everyone!

When the server causes a delay between the first and second serve, he has one serve to come. When there is a delay between serves that interrupts the natural flow of the match and when the delay is caused by the receiber or outside interference, the server has two serves to come.

In general, any conversation between partnets while the ball is moving toward their opponents' side of the net is taboo; once either you or your partner has hit the ball, don't say anything until an opponent has hit it. Even when the ball is moving towards two partners, conversation between them should be minimized, with about the only words permitted being such exhortations as to try hard for a ball ("run!") or to let one pass ("out!"). Incidentaly, "out" as advice to a partner to let the ball drop does not suffice for the normal "out" call necessary when a ball has landed outside the court.
