You'll know it when you see it—look for the window envelope with the big tennis racquet in the corner!

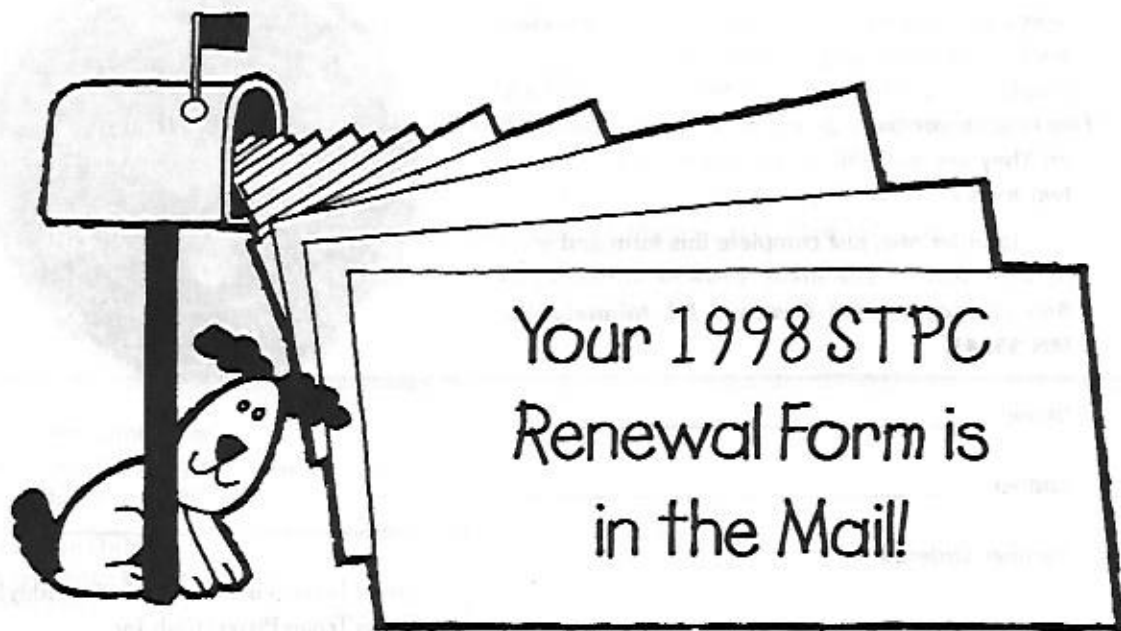
Like last year, your renewal form is an invoice. It shows your membership information—your name, address, phone number, skill rating, and other data—as it

## 1997 Stecklein TeamTennis Winners

Brown's team captured first place by winning 80% of all games played. They tied 4-4 with Deni Sahr's team in the playoffs, with Sahr's team winning 75.5%. Nine Level A teams completed the season.

Rincon's team captured Level B honors, winning 87.5% of games played. They were opposed by four teams.

Tuesdays (play day) brought much too much rain. Rescheduling rainouts proved the main problem for captains, along with a scarcity of subs.

A picnic at Snail Lake Park in late August ended the season. About fifty picnickers enjoyed an afternoon of volleyball, kickball, badminton, good company, and good food.

"The success of the 1997 program is largely due to the extra effort put in by the captains and, especially, Deni Sahr, Jan Hagen, Jack Wallin, and Carol Hall," said coordinator John Connelly. "And the east captains really appreciate the work of Marianne Davidson in finding courts."

### Playing Nice: Encouraging Civility on the Courts

By **Bob Tischbein**—*There are rules and customs governing the playing of tennis that promote fairness and civility. Some of you might not be aware of them—after all, how many of you have read the USTA Rule Book? Here are a few "rules of the road" that are frequently violated. Look them over and mention them to your playing group if you think they're being ignored. Playing nice makes tennis so much more enjoyable for everyone!*

Let's talk about tennis subs, and walking across courts.

When a sub has agreed to fill in for you, the sub has an obligation to play as agreed and to be on time. Likewise, you have an obligation to your sub. You might find out at the last minute you can play, and so you don't need the sub. You should be considerate and call your sub to let him know he's not needed. After all, he rearranged his schedule to help you out!

We've received complaints about seniors walking across the court while tennis is in progress. Always use the passageway behind the court—don't cross Court Three to get to Court Four! As seniors and members of STPC we have an obligation to set an example. ■

## Prince Concerned about Scarcity of Scientists of Color in the World

**By Norm Diamond**—Before tackling the serious subject reflected in the headline, there's the matter of the shoving incident between Venus Williams and Irina Spirlea during the recent Women's Tennis Open in New York City. Venus' father, Richard, stated the situation was strictly racist while Prince remarked, "I believe Spirlea's competitive anger accounted for seventy percent and racism thirty percent." Prince further believes that Venus Williams behaved admirably in light of the tense situation. In the famous words of a noted diplomat, "The prince must be a lion but he must also know how to play the fox."

Regarding the scientist question, there's a preface that plays out a warm relationship. George Dixon, retired chairman and CEO of First Bank Systems, Inc., and Luther Prince, at that time director of Inner City Business Ventures in Minneapolis, were concerned about the relatively small number of scientists of color. Prince wanted to repay his good friend Dixon in some way for helping him with a business problem many years ago so he asked for suggestions.

"If you look at the advanced degree recipients in science and math," Dixon said, "this is wrong and we ought to take a firm stand to encourage people of color to become interested in math and science." What better combination than a black scientist and white banker to put their heads together and create some positive action. As an initial result, two Macalester College students of color spent an entire

summer engaged in scientific research. Both students aspired to medical school after college. Their summer experiences helped them prepare for it and enhanced their prospects.

Inspired by his collaboration with Dixon, Prince worked with the Minneapolis Foundation to create special summer research stipends for students of color to work with faculty in the natural sciences. The grants came from a fund at the foundation established by Prince and wife Evelyn.

Prince has a simple philosophy, i.e., "there are many opportunities for achievement and we must prepare ourselves. You never know what will happen." Some of his favorites are: soul food, Chardonnay wine, Monica Seles and Pete Sampras for tennis, Robert Smith of the Vikings, and Kirby Puckett of the Twins. He stresses government is involved in too many community projects and cites the need for independent participation. As a liberal, he is interested in conservation, social issues, and fiscal responsibility.

His pet peeve is a driver who cuts in front of him in traffic. Hobbies include tennis, golf, and surfing the Internet. Prince has traveled widely throughout Europe, for both leisure and the Honeywell organization. Although he thinks the State of the Union is good, he decries the indifference affecting the inner city. Extremely satisfied with his career in the corporate world, Prince still yearns to have been a computer programmer. Currently serving on the Boards of Dunwoody Industrial Institute and Saint Paul Academy, he's a most happy fellow. And why not? He's a Prince of a man!

# Captains' Profiles

## Mary Wenz

**By Carol Hall**—A newcomer to Mary Wenz' Decathlon league is first struck by her soft soothing voice; then, her pretty smile. Opposing Mary on the tennis court, he discovers she 's a fine athlete. Officially rated 3.5, Mary learned singles in high school. She was first introduced to doubles in 1989 upon joining STPC, and has since steadily improved her game.

Mary is just as proficient at downhill skiing. But beyond expertise, skiing changed her life. She married a fellow skier, met at a ski function; she moved West to ski the Rockies, abandoning lifelong Saint Paul roots.

Mary settled in Great Falls, Montana where she began her first teaching job following college. However, Great Falls skiing proved not so great: "It was 1954, and Great Falls' only ski area, King's Hill, was open only on Sundays. There was just a rope tow, one mile long, and people would tire and fall off on the way up. When you finally got to the top, you skied down following ruts. For good skiing we'd go to Whitefish. There the trails were

all groomed and there were T-bars. It was just heaven!"

Unlike King's Hill, the job teaching fifth grade couldn't have been better. Mary loved the spectacular mountain view from her classroom. She was delighted to find the school filled with young teachers like herself, just out of college. Many were from Minnesota and North Dakota, as recruiters scouted colleges in those states to hire teachers who wouldn't complain about the Montana cold.

Mary loved the west. Yet she returned home to flatland in 1960, after having followed teaching jobs and snow to Bremerton, Washington and Denver, Colorado. For the next five years, she taught sixth grade at Harrison School in Saint Paul. And in 1964, Mary traded her Scandinavian surname of Borgeson for Wenz, marrying Chuck Wenz, a Sperry Rand mechanical engineer.

Chuck and Mary are particularly proud of their two children. Both are distinguished alumni of Luther College. Cathy Wenz graduated summa cum laude and Paul, magna cum laude. They also are members of Phi Beta Kappa. Now in their early thirties, Cathy is a statistician for Intel Corporation, and Paul is a chemist for H.B. Fuller.

This summer the Wenz clan camped out in the Black Hills. "It was like old times," Mary related, harkening back to camping trips when the kids were young. "Except, back then we looked out for them, and now they look out for us!"

Mary is finishing a three and a half year stint on the STPC Board of Directors. Another of her attributes, as any board member will attest, is excellent organization. The fall and winter tennis parties are successful largely because, as party chairman, Mary leaves nothing to chance. She supplies volunteers with a comprehensive list of tasks, evenly spread out, without a lot of work for any one person. And, to the delight of STPC treasurer Jim Tornoe, the parties often reap a small profit, unlike some other club events that go into the red!

The baby grand piano in Mary's living room evidences another of her long-term pastimes, as she's played piano since age eight.

Throughout the Wenz house in West Saint Paul are oil paintings, the result of a more recent hobby and the practical application of Mary's college minor of art education.

Yet, she declares, "Tennis is the highlight of my week." A captain for seven years at Decathlon, Mary also plays at Wooddale, and summers, Inver Grove Heights. She's also on a championship USTA team which competed in the nationals in Tucson in 1994. Of the two, Mary prefers Senior Tennis for the camaraderie and because "you don't keep track of wins and losses."

Comparing skiing with tennis, athlete Mary Wenz at 64 says, "You're physically limited in skiing when you get older. Today I can't ski as well as when I was young. But tennis is different. Older people can improve at tennis doubles. Each year I get better at it. Tennis is the big thing for Chuck and me." ■
