Playing Nice: Encouraging Civility on the Courts

By Bob Tischbein—The Jack Dow Annual Senior Tennis Tournament is coming up September 8, so let's review the USTA Code of Conduct for tournament play.

1. Once you have entered a tournament, honor your commitment to play. Exceptions should occur only in case of serious illness, injury, or personal emergency.
2. From the beginning of the match, play must be continuous. Attempts to stall or extend rest periods for the purpose of recovering from a loss of physical condition, such as cramps or shortness of breath, are clearly illegal.
3. Intentional distractions that interfere with your opponent's concentration or effort to play the ball are against the rules.
4. Spectators, including friends and coaches, are welcome to watch and enjoy matches. Their role, however, is clearly restricted to that of passive observer with no involvement of any kind during the match.
5. Players are expected to put forth a full and honest effort regardless of the score or expected outcome.
6. Players are expected to maintain full control over their emotions and the resulting behavior throughout the match. If you begin to lose your composure during play, try the following:
 - Take several deep breaths, exhale slowly as possible and feel your muscles relax.
 - Concentrate on your own game and behavior while ignoring distractions from your opponent or surroundings.
 - Be your own best friend. Enjoy your own good shots and forget the bad ones.

Captain's Profile

Aldean Cummings

By Carol Hall—Travel is Aldean Cummings' middle name. Many trains, planes, and automobiles have transported her around the globe.

It all began in the 1950s with her first major trip. During college summer vacation, Aldean traveled abroad with the American Youth Hostel program. The group of students took a slow boat to Europe where they bicycled through England, Belgium, and Holland, and hitchhiked Germany and France. "That was the greatest summer of my life!" she exclaimed.

And the motivation for many future journeys to destinations including China, the Mediterranean, Scotland, and Ireland. Most recently, Elderhostels abroad have been on Aldean's itinerary. And she's currently

looking at the possibility of touring Russia on a Swiss riverboat "with good food."

Between travels, Aldean married, raised two sons, and taught school. Now 66, she's retired and living in a setting she particularly loves.

"I have a perfect view of the water, the sailboats, on Lake Minnetonka," she said of her Excelsior condominium. "The July 4th fireworks seem as though they are put on just for me." That the condo is on the site of the former Excelsior Amusement Park which Aldean enjoyed as a kid further adds to the pleasure of living there.

"In retirement I wanted to do completely different things," Aldean said. Consequently, the former schoolteacher shed all traces of her profession, even dropping out of AAUW. To add new dimension to her life, she took up tennis. Beginning in 1993 with Percy Hughes's drills, Aldean has worked off and on at her game. "I love it, but I'd like to get better," she said. "My dream is to be a 3.0 player." With that in mind, Aldean co-captains summers at Brookview

Park and winter, Nicollet Tennis Center, and plays in a USTA 2.5 league.

Another of Aldean's favorite pastimes—although not new—is the theatre. A long-time devotee of the Guthrie, Aldean is ecstatic about the new Irish director Joe Dowling. She fairly sparkles describing Dowling's adaptation of Shakespeare's "Much Ado About Nothing," as well as "Philadelphia, Here I Come," written by a contemporary Irish playwright. "The fun, the lightness. There's so much humor, frolicking. It's such good entertainment," she said. "I like plays for the emotion and feeling behind the drama."

Local author Jon Hassler evokes a similar enthusiasm. Hassler, who frequently writes about teachers and teaching, prompts *deja vu*, bringing Aldean back to her education years and the people she knew then.

During her career, Aldean taught junior high classes in Seattle, Washington, Springfield, Massachusetts, Edina, and Hopkins. She retired in 1992 from teaching in the Hopkins schools.

Tall and slender, with a warm smile and personality, Aldean has been widowed since 1983. Her husband, Francis "Chuck" Cummings, was a New Englander from Massachusetts. A stockbroker and later in sales, Chuck for a time operated a fast food restaurant, Cummings, at Highways 101 and 7. Son Mike is an internist at Abbott Northwestern Hospital, and Steve runs an environmental testing company in Eden Prairie. Their seven children spend much time with Aldean.

A native Minnesotan, Aldean grew up in Chaska. She graduated from the University of Minnesota, where she belonged to Alpha Chi Omega Sorority.

Aldean officially ended her teaching career on a dramatic note. During the summer of 1992, she spent a month teaching English to Polish youngsters in Poland. True to form, Aldean then took the opportunity to travel through eastern Europe.

And never let it be said that tennis has kept her
