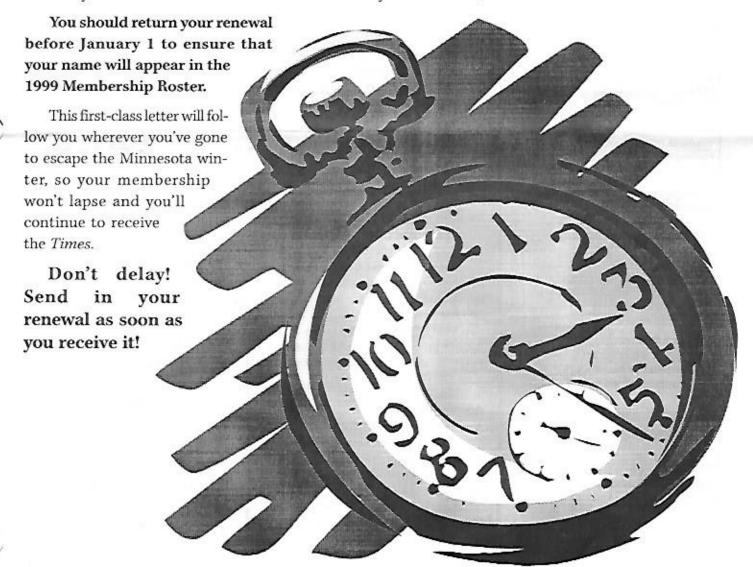

Report from the President

By Bob Tischbein, STPC President—The STPC board of directors met October 1 at Hosmer Library for a two-hour meeting. The following are highlights from the meeting. (Next meeting: November 19 at the Roseville Public Library.)

Officer Report

Bob Tischbein introduced two new board members, Jan Hagen and Mel Baken,

Old Business

Jack Dow Tournament (Percy Hughes). The third year of the tournament was a success except for some no-shows. The 98th Street Northwest Tennis Club was ideally suited for the tournament.

Membership (Grayce Aberle). Membership on Oct. 1 was 1,771. Projected total, Nov. 1 is 1,800 and 1,900 for Jan 1, 1999. To achieve these goals she requested board assistance; help from the membership is also needed. 85% of all new members come through current members efforts. An appeal for aid from members should appear in the Times.

Parties (Jan Hagen). Jan announced the tennis party schedule (see schedule, page 2, this issue).

Facilities (Jack Wallin). Jack reported that both St. Paul and Minneapolis facilities are more than adequate for current club needs.

Newsletter (Bev Sinniger). Bev met with editor Nancy Kaminski to discuss cost cutting and improvements. Board discussion included condensing captain profiles, using less white space, and limiting function announcements to a half page.

Also under consideration is combining the December/January issues. The deadline has been moved from the 20th of the month to the 10th. The board praised the *Times* as a quality publication but said improvements should be considered.

New Business

A motion was made that STPC functions cannot have expenditures other than those pertaining to and for the sole purpose of the function. It was passed unanimously on a hand vote.

Bob Tischbein announced that chairpersons are needed, and received a good response:

By Ron Liddiard—Calls that you can make against yourself are one of the following:

- · The ball touches any part of you or your equipment
- · The player's racquet touches the ball (a "tick")
- The player touches the net. You have to stay clear for two bounces of the ball; the first bounce determines in or out, and the second determines that the ball is unplayable.
- The player hits the ball before it crosses the net.
- · The ball takes a double bounce.

Captains' Profiles

Ronnae Wagner



Although comfortably settled in Minnetonka, Ronnae left her heart in south Minneapolis. It's where she spent her childhood and much of her adult life.

"I had a tiny house in the wonderful Linden Hills area, near the lakes," said this pleasant woman with the uncommon name. "I loved living there."

Then Ronnae was into her career. Starting in 1965 as an administrative clerk, she even-

tually was promoted to Director of the Admitting department at Metropolitan Medical Center and in charge of thirtytwo people.

"Every day was interesting," she said. "But it was a tough job because there weren't many rewards. The patients think you take too much information, the business office, not enough. At the same time, it was extremely important work."

Ronnae, who is 65, took early retirement in 1990. That same year she married Howard Wagner, a lab salesperson for Methodist Hospital. "Everyone assumes we met through Senior Tennis, as Howard's also an STPC member," Ronnae said.

Actually, their first meeting took place in a very unlikely setting. Each, sadly, had a spouse with terminal cancer, and they attended the same cancer support group. Ronnae's husband succumbed in 1982, Howard's wife in 1985.

Having lost spouses to cancer, Ronnae and Howard have forged a unique bond. "We share things most people couldn't understand," she said. "We feel lucky to have found each other."

Ronnae was no stranger to tragedy when she lost her husband. "So many other people in my life have died," she said. "And they died so young, in their twenties and thirties. No one else in my family ever reached my age."

Ronnae's bravely weathered it all, remarkably with no visible scars, but rather with a deep appreciation of her longevity and the good life she shares with Howard.

A life that finds her still bowling with an MMC league. Involved in many other activities, she spends time with her son and grandchildren, Erin and Conor Garrity. Serving her church, Westminster Presbyterian, Ronnae assists with dinners and refreshments for special functions.

Aside from a yearly October stay at romantic Naniboujou Lodge on the North Shore, Ronnae and Howard are not much for travelling. Homebodies, they live in Howard's large house,

where he reared his eight children. But they do enjoy entertaining and the house is ideal for their big parties. "We give at least one Christmas party for all the people we play tennis with," Ronnae said. "And every year we host Breakfast at Wimbledon for about thirty people." This event, complete with the traditional Wimbledon strawberries and cream, is always held on a Saturday morning during the Wimbledon women's finals.

Senior Tennis figures heavily into Ronnae's schedule. More "a helper than a leader," she volunteered for phone duty for the recent Jack Dow Tournament, making two hundred calls to participants, with their starting times. Ronnae also worked the October tennis party.

"I'm willing to help," she said, "and I'm extremely committed, and always do what I say." She believes everyone should follow suit, for without volunteers there'd be no STPC.

Ronnae plays tennis four times a week. This includes cocaptaining 3.0 and above leagues at Nicollet Wednesdays and Fridays. The last two years she also captained for TeamTennis. Winning gold and bronze medals at the July Duluth Northland Senior Games qualified her for the Orlando Senior Olympics in 1990. Not bad for one who "never touched a tennis racquet" till age 56. But Ronnae loves sports. She played softball and unusual for the late 1940s—lettered in girls' basketball at her alma mater, West High.

Ronnae finds much to like about suburbia. But she'll always miss Linden Hills, and the sounds of Lake Harriet band concerts drifting through her windows on summer nights.

As for her name, she can't explain the spelling, which appears a misspelled version of 'Rene'—but she can with grandson Conor. "One N instead of the usual two," Ronnae says, "means he's Irish!"
