## Captains' Profiles

#### Stan Hill

At 84, Stan Hill is STPC's oldest captain. But advanced age hasn't slowed Stan's powerful serve. If anything, it heightened his appetite for a new challenge: when he turned 80 he began writing books.

Stan's first, his autobiography, is aptly titled Confessions of an 80 Year-Old Boy. Structured as "a blueprint for true happiness and successful living," Confessions traces Stan's route there, guiding the reader along the same path.

And Stan unquestionably is a happy man. Upbeat and optimistic, unfailingly polite, he clearly delights in a long life well lived: a demeanor that often mistakes him as a clergyman! Stan is, however, a retired executive of a Fortune 500 company, which is where his business success began.

He was hired by Minnesota Mutual Life Insurance Co. in 1930, when he was sixteen. Starting as an actuary, earning \$52 a month, Stan eventually rose to senior vice president.

Retiring from MML in 1968, Stan began a new career. He founded a firm to help small companies set up computer systems. "I entered the field at a very opportune time. Clients actually came to me," said Stan. "I enjoyed helping people, and I made more money than as a senior vice president!"

The pinnacle of Stan's career came in 1980 when he began serving on the board of Hadco, a small printed circuit manufacturer. "It greatly expanded my business horizons. The board had intelligent, knowledgeable men from so many dif-



ferent walks of life. I learned so much from them. Of course I held stock in the company, which greatly enriched my estate."

The profits also enhance Stan's practice of "generous giving," outlined in Confessions.

Not bad for a poor farm boy from Ontario. Stan's family emigrated to Minnesota when he was nine, settling in White Bear Lake, where he makes his home today. Stan graduated from high school at fourteen, having skipped several grades. In 1938, he married a pretty White Bear Lake girl he met at a Presbyterian church meeting. He was an officer in the Army during World War II, serving in Italy.

Celebrating their 60th wedding anniversary in August, Stan and Doris treated their five children and grandchildren to an 11-day Vancouver to Anchorage cruise. Describing the highlight of the cruise, Stan said, "We were one quarter mile off the Hubbard Glacier, which is five and a half miles wide, 300 feet high, a virtual wall of blue-white ice. I got an action shot of calving, as huge chunks broke off to make little icebergs."

Stan thoroughly enjoys every aspect of travel. Another recent trip took him to Singapore for a Hadco board meeting at the world-famous Raffles Hotel and to oversee a startup plant in Kuching, Borneo. Not only did Stan rave about his exotic destinations, he somehow managed to enjoy the forty hours of flying it took to get there and back!

Volunteering brings Stan a different sort of enjoyment. Over the years he's donated hundreds of hours as an investment advisor to schools and foundations and to serving on the board of United Hospital.

The aftermath of Confessions' success absorbs another large chunk of time. To Stan's delight, it sold 2000 copies, which encouraged him to write a novel. Both books spawned his publishing company, Red Oak Press, a going business that takes on other clients. And the books were responsible for yet another new discipline, public speaking. Following tennis, Stan draws whistles from his players, having changed into suit, tie, stylish wide brimmed fedora and trench coat, as he's off to a civic club or church group to hype his books!

As for tennis, Stan believes "old age doesn't cause inactivity, inactivity causes old age." Consequently he gets in as much tennis as possible, playing Mondays, Wednesdays, and Fridays. (He pumps iron Tuesdays and Thursdays!) Stan also makes one winter trip to Vail to downhill ski. Summers find this octogenarian bicycling and windsurfing on White Bear Lake—once, in formal attire for a magazine photo!

Like the Energize Bunny, Eldercaptain Stan Hill just keeps on going and going and going!
