## Register Early for Stecklein Team Tennis

By Carol Hall—Interested in competitive tennis? Willing to drive a ways to play? Available Tuesday mornings? If so, Stecklein Team Tennis is for you.

Form your own team (four men and four women of like skills) or we'll assign you to a team in your locale, and prepare to enjoy summer, competing in this traveling league.

Matches are played Tuesdays, 9-11 a.m., at outdoor courts throughout the Twin Cities. Play commences June 15 and winds up August 17 (ten weeks).

Each team has a captain. A roster of like-skilled substitute players is available to the captains.

Originated by former STPC president John Stecklein, Team Tennis began five years ago. It's structured as a summer-long tournament with playoffs at the end. Games are divided into mixed doubles, men's doubles, and women's doubles.

Last year eleven teams competed. Organizers are hoping for even more teams in 1999, as larger numbers make it possible to arrange play in courts closer to home, cutting down travel time.

Organizers also encourage you to register early, so they can assess the need for courts and reserve them ahead of other groups. To register, complete the form on this page and mail it to the appropriate coordinator, listed at the bottom of the form.

Last year's players are urged to contact their captain should they wish to compete on the same team in 1999.

Don't delay—competition, fun, and new friendships await you on the summer courts!

#### Civility on the Courts

By Ron Liddiard—Question: When is a stroke a double hit (sometimes known as a "carry")?

The USTA rules say a stroke is a double hit when "in playing the ball the player deliberately carries or catches it on his racquet or deliberately touches it with his racquet more than once."

The USTA then goes on to comment, "Only when there is a definite second push by the player does his shot become illegal, with the consequent loss of point. The word deliberately is the key word in this rule. Two hits occurring in the course of a single continuous swing are not deemed a double hit."

This is a self-call by the player, or the player's opponent can ask if he or she sees it happen.

From personal experience, I know that it is not always easy to play with civility, but keep trying. It makes the game more fun to play!

# **Captains' Profiles**

#### **Bob Thoreson**

How can youthful appearing Bob Thoreson possibly be 70?


Good genes, in part. Inheriting his Scandinavian parents' easygoing attitude spared Bob frown lines. A lifetime of hunting, skiing, bicycling, and tennis accounts for his good color and tip-top physical condition.

Sports also helped Bob cope with a stressful career. A commercial artist, he was doing work he loved. However, the pressure of meeting deadlines became overwhelming. Burned out, Bob retired early, in 1990, after 40 years in the business.

He ended his career as art director for Lawrence Sign Co., a Saint Paul firm that designs illuminated signs. Bob sketched drawings for fluorescent and neon signs, of the kind used in Las Vegas. He worked there 26 years.

Bob began in the 1950s as a sign artist. Working for Halloran Sign Co., he could be found up on a hoist, hand painting on a bulletin board a giant bottle of Jim Beam whiskey, or a four-foot image of the Saint Paul Winter Carnival Queen of the Snows. Bob also did lettering on buildings. "Henley Furniture Co." in six-foot letters on the side of this three story furniture store in South Saint Paul, is an example of his work. (Bulletin boards are not to be confused with bill-boards, on which images are wallpapered.)

"Then, if you were artistic you could make it in the business," Bob said. "Now it's all done by computers."



In a perfect world, Bob would have gotten a job with his favorite company, NSP. "I'd get their benefits of six weeks vacation, hospitalization until death and paid holidays," he said. "Then I could have had art not as a career, but a hobby."

Once retired, Bob put away his brushes and pencils and dusted off his tennis racquet. Having already learned the rudiments, he joined STPC and began polishing up his game, playing at Wooddale. This leg to his captaining there during "prime time" on Mondays, 10–12 a.m.

"I wish I could play tennis as well as I ski," laments Bob (who incidentally is rated 3.5). A downhill skier and racer for 42 years, Bob loves the sport. Indeed, skiing is a Thoreson family passion. Two grown sons and three daughters are all accomplished skiers, who have taught skiing locally at Afton Alps. One son presently lives in Utah, and is an instructor at Snowbird, having learned from 'the best instructors in the world"

Bob, who's skied both local hills and mountains, has no preference. "The fun is all in making nice crisp turns," he declared.

Archery has been a part of Bob's life as long as skiing. He's been active in a local archery club and has bow hunted throughout the West, Midwest, and Canada. "I've shot countless deer, clk, and moose," he said. "And I like to be outdoors in the woods." By avoiding the gun hunting period, he also is able to find solitude there.

Our mild December weather allowed for another of Bob's favorite summer pastimes, bicycling!

Growing up in West Saint Paul in a happy family of two brothers and three sisters, Bob attended Humboldt High. In 1945 he joined the Navy and was based in Pearl Harbor. "I raised a little heck there!" he declared, flashing his ready smile

Once home, Bob got serious. Using the GI Bill, he embarked on a four-year art program at the Minneapolis School of Art and the Saint Paul School of Art, graduating in 1952. "I always kinda liked to draw," said Bob, who preferred sketching "cowboys, horses, active stuff, not landscapes."

Mendota Heights is home to Bob and Bev, his wife of 47 years. "We're very happy together," he said. "If I had it to do over, I'd get the same girl." Indeed, Bob's tennis league is social tennis rather than heavily competitive, as he enjoys having the opportunity to play tennis with Bev. Bob also appreciates Bev's help organizing the league. Calling her his cocaptain, he said, "We do everything together."

Marital bliss further explains the Thoreson fountain of youth. But Bob sums it up in three words: "I think young!"
