Club By-Laws Amended

On January 1, 2001, an amendment to Section 4.1 of the STPC By-Laws goes into effect. Section 4.1, Management, reads:

"The control, business, and management of the affairs of the Club shall be entrusted to and vested in a Board of Directors composed of 18 directors, including the Immediate Past President."

The amendment, designated Section 9.6 of the By-Laws, reads:

"This amendment reduces the number of members on the Board of Directors from 18 directors to 12 directors."

Tennis in Japan

The Japanese tennis players were 3.0 or better, and lots of fun. Besides the great tennis, especially memorable was the four nights' stay in the homes of host families, who took the Americans to their assigned courts in the mornings and came for them in the late afternoons.

The trip was arranged and led by Lois Sonstegard, fostered by the Minneapolis-Ibaraki City sister city program.



Percy Hughes:

A Pro in Both Tennis and Music

Percy Hughes received his first clarinet at the age of 11, and hasn't stopped playing since.

That first clarinet was a Christmas present. Since that December in 1933, he's given the Twin Cities jazz played on the alto, tenor, and soprano saxophone as well as the clarinet.

Percy has entertained audiences since 1946, when he formed the Percy Hughes Orchestra after being discharged from the army. They played all the campuses in the Twin Cities area, and club dates in both Minneapolis and Saint Paul.

In 1950 his group became regulars at the Flame, and later, in 1956, began a 17year gig at the Point Supper Club.

Percy found, though, that it was difficult to make a living on music alone, so he began a 30-year career as a postal carrier.

While at the Post Office, he became the assistant chairman of the Post Office Sports Council. He noted a lack immediately—and started a tennis program.

Percy needed an instructor, so he took lessons from local tennis greats (including our pro, Ernie Greene) and in turn taught what he learned to the participants in the Post Office tennis program.

So for 26 years, Percy was leading an

orchestra five to six days a week, delivering mail five days a week, teaching tennis to his coworkers, and still finding time to have a home life. Of course, he only slept four or five hours a night to fit all these activities in.

After Percy retired from the Post Office in 1982, he heard about the Senior Tennis Players Club. He contacted the club founder, Jack Dow, and volunteered to teach beginners lessons.

As STPC grew, Percy decided he should become a certified tennis instructor. Accordingly, he applied to the USPTA for certification, and after passing the grueling four-hour written examination and the on-court test of his abilities to execute every stroke in tennis, Percy became the oldest pro to pass. He was 63 at the time, and the next-oldest person to pass was 37!

Percy continues to be very active on the Minnesota jazz scene. In 1987 he was inducted into the Minnesota Jazz Hall of Fame, and in 1996 into the Minnesota Music Hall of Fame. His music is part of a five-year exhibit at the Minnesota History Center entitled, "Sounds Good to Me: Music in Minnesota."

Percy still performs with his group at venues such as St. Paul's Artists' Quarter and



the Dakota, and teaches private lessons, presents programs and workshops at schools and colleges.

And of course, you can find him still teaching seniors the joys of tennis.

Thanks, Percy, for all you've given people in the Twin Cities, both culturally and athletically. We're all the better for it.
